ARE-QP Awards Process

ARE-QP stands for:

ANQ Recognition for **E**xcellence in **Q**uality **P**ractice.

This award not only provides recognition to the organization performing excellent work in the field of Quality Management and Practices, it improves the visibility of ANQ as an organization promoting quality movement in Asia.

ARE-QP Awards Process

Purpose

ARE-QP award shall be given to organizations which have excelled in any Quality Promotion Activity leading to outstanding achievements. Keeping in view different levels of development in different parts of Asia, the award will be activity specific and not the organization specific. Examples are:

1. Creating perfect line for zero defects (Aishin Seiki Co.); and
2. Build in quality with ownership (Toyota Motor Co.).

ARE-QP Awards Process

Activities

Some project examples are:

1. Enhancing top leadership and enabling organization management effectively and efficiently
2. Enhancing and supporting improvement of quality, cost, delivery, safety, environment and so forth
3. Supporting standardization and daily management for effective and efficient implementation
4. Supporting new product, service and technology development effectively and efficiently

ARE-QP Awards Process

Activities

Some project examples are:

5. Collecting, analysing and implementing quality information for effective and efficient TQM
6. Deploying small group activity and education and training system
7. Any other TQM promotion activity

ARE-QP Awards Process

Nominations

All member organizations are requested to name one or two activities as per examples mentioned above, along with the name of the organization implementing the proposed activity which could be considered for recommending ARE-QP award.

ARE-QP Awards Process

Criteria for the Award

Criteria for recommending an organization adopting an activity leading to outstanding achievements will be its:

1. **Effectiveness:** It is implemented in organization and leads to improved performance
2. **Repeatability:** It is formulated as a system and enables to improve performance in similar situation
3. **Innovativeness:** It contributes to TQM progress because of its innovativeness

ARE-QP Awards Process

Selection

ANQ Country representatives will send proposals of ARE-QP Award nominations to the ARE-QP Chairman.

ARE-QP Committee under the chairmanship of Mr. G.E.Tan will take a final decision regarding the suitability of the activity proposed and the choice of organization recommended for the award.

ARE-QP Awards Process

Closing

It is proposed that organization selected for ARE-QP Award be requested to make a presentation on the activity being undertaken leading to outstanding results in a special session at the Award Closing Ceremony planned during the ANQ Congress 2023. A Plaque is to be awarded to the winner.

Time for making such presentation by the Award winning organisation shall be limited to 15 minutes (excluding Q & A).

The respective nominated organization will have 2 mins, just before the presentation, to introduce themselves.

ARE-QP Awards Process

Proposed ARE-QP Timeline - 2023

- 03 Apr 2023: Publicity drive to recruit suitable organization candidates
- 30 Jun 2023: Sending recommendations of Nominees for Award
- 31 Jul 2023: Abstract submission
- 18 Oct 2023: Presentation by awardees (during the first day of Congress)
- 19 Oct 2023: Presentation of Award to Winners (during the closing ceremony of the Congress)
